## ACCIDENT WAIVER, RELEASE OF LIABILITY AND INDEMNITY/HOLD HARMLESS AGREEMENT

I acknowledge that this Accident Waiver, Release of Liability and Indemnity/Hold Harmless Agreement form will be used by West Bloomfield Parks and Recreation Commission and the Charter Township of West Bloomfield and event holders, sponsors, and organizers and that it will govern my actions and responsibilities at the West Bloomfield Parks and Recreation Commission Dog Park (WBDP). I certify that I am physically fit to bring my dog to the WBDP and have not been advised otherwise by a qualified medical person. I acknowledge that the use of the WBDP is potentially dangerous and involves the risk of injury, death or property damage. I assume full responsibility for the risks associated with the use of the WBDP. In consideration of my participation in WBDP, I hereby take action for myself, my executors, personal representatives, administrators, heirs, next of kin, successors, and assigns to: (A) Waive, Release, and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me, including as to my traveling to and from the WBDP, the following entities or persons: West Bloomfield Parks and Recreation Commission and the Charter Township of West Bloomfield, their elected and appointed officials, employees and volunteers, and representatives and agents, and others working or acting in behalf of West Bloomfield Parks and Recreation Commission and the Charter Township of West Bloomfield; and to the extent permitted by law (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of or relating to my attendance at or participation in the West Bloomfield Parks and Recreation Commission Dog Park.

I hereby consent to receive medical treatment, which may be deemed appropriate in the event of injury, accident, and/or illness.

I accept full responsibility for any and all injury to any person, or damage to any property, in connection with the use of the WBDP by myself or by any dogs which I bring to the WBDP.

I agree to abide by the Rules and Regulations of the West Bloomfield Dog Park (WBDP) and all West Bloomfield Township ordinances.

## Rules and Regulations

1. \_\_\_ Permit holders are responsible for compliance with the West Bloomfield Dog Park rules and regulations listed in this agreement at all times.
2. \_\_\_ Neither, West Bloomfield Parks and Recreation Commission nor the Charter Township of West Bloomfield are responsible for permit holder's dogs or any injuries caused by their dogs.
3. \_\_\_ Use of the West Bloomfield Dog Park is at the permit holders' own risk.
4. \_\_\_ Permit holders and their approved dogs are the only ones allowed to use the West Bloomfield Dog Park. Your permit can be revoked if you allow a non-permit holder or unregistered dog into the park.
5. \_\_\_ The following are not permitted in the West Bloomfield Dog Park: dogs in heat; dogs under the age of four months; dogs with contagious diseases or parasites; pinch, prong or shock collars; aggressive dogs; dogs that have been identified as dangerous by the Township or court of law; people food or dog food (including treats); alcoholic beverages; glass containers; cigarettes or cigars.
6. \_\_\_ Dogs must be on a six-foot leash until inside enclosure.
7. \_\_\_ Up to 3 dogs per household may be registered. Two dogs per owner/handler are allowed at one time in the park.
8. \_\_\_ Dogs must be actively supervised and be under voice control of their owner(s).
9. \_\_\_ Permit holders must remain with their dog inside the West Bloomfield Dog Park at all times.
10. \_\_\_ Owners must clean up their dog(s)' waste and deposit it in the receptacles provided.
11. \_\_\_ Digging is not allowed in the West Bloomfield Dog Park. Owners are responsible for filling in any holes dug by their dog(s) by using the dirt provided in the designated bin.
12. \_\_\_ Laptop/tablet use is not allowed in the Park. Limit any phone conversations to under 2 minutes to ensure your dog is properly supervised.
13. \_\_\_ Dogs barking excessively or exhibiting aggressive behavior must be removed from the Park at the first sign of this behavior. Any dog that bites another dog or human and is deemed unfit for the park, will no longer be allowed in the park and will be immediately removed from the owners permit.
14. \_\_\_ Dogs must wear their Oakland County license tag, as well as the annual West Bloomfield Dog Park tag (received upon permit purchase) at all times.
15. \_\_\_ No acts of aggression will be tolerated; either verbal or physical, by a permit holder towards another permit holder or another permit holder's dog.
16. \_\_\_ Toys are permitted at the West Bloomfield Dog Park; however, should any dog become possessive, the toy must be removed immediately.
17. \_\_\_ Adults (18 years and over) may apply for a permit. Children ages 14-17 are permitted at the West Bloomfield Dog Park if they are under the adult supervision of a permit holder. Children under 14 are not allowed in the West Bloomfield Dog Park.
18. \_\_\_ The Park is split into three sections: One section for all dogs, one section for small dogs up to 25lbs, and one section for people and/or dogs with disabilities.
19. \_\_\_ In the event that any of the above rules are violated by a permit holder or a complaint is made by another permit holder, West Bloomfield Parks reserves the right to immediately suspend or revoke permits of all parties involved. Disciplinary actions do not take place without an investigation by a Parks and Recreation representative. Complaints can be submitted in writing by visiting [www.wbparks.org/dog-park](http://www.wbparks.org/dog-park) Complaints must be received within one week of the incident. Anonymous reports will not be allowed.
20. \_\_\_ The West Bloomfield Dog Park may be closed (partially or fully) at times in the Spring & Fall for park maintenance and potentially in cases of excessive rain when it is deemed too muddy by WB Parks Staff.
